## **Grant Programs Now Accepting Applications:**

### Wisconsin Help for Homeowners Program Now Accepting Applications



<u>Wisconsin Help for Homeowners program</u> is providing \$92 million in federal funds announced by <u>Governor Tony Evers</u> to help folks stay in their homes, catch up on bills, and avoid foreclosure.

The program is open to individuals and families who live in Wisconsin with overdue housing-related bills, both with and without a mortgage, who meet income and other eligibility requirements, and

have experienced a qualified economic hardship since January 21, 2020.

#### **Workforce Innovation Grants: Round 2 Applications Due April 18**

Governor Evers previously unveiled 12 regional projects set to receive up to \$60 million dollars in Workforce Innovation Grants. These grants will help provide long-term solutions to Wisconsin's workforce challenges for communities across the state.

Round 2 funding will make available up to \$40.5 million to promote local and regional solutions to ongoing workforce challenges, with grants ranging from \$250,000 up to \$10 million. **Applications opened on February 22 and will close**

#### **Main Street Bounceback Grants - Application Period Ongoing**

The Main Street Bounceback Grants program has so far provided \$10,000 to more than 3,400 new or existing businesses and non-profit organizations moving into vacant properties in Wisconsin's downtowns and commercial corridors. The program is still open to new or existing businesses opening a new location or expanding operations in a vacant commercial space as of January 1, 2021. Grant funds are available as part of the American Recovery Plan Act and distributed by the Wisconsin Economic Development Corporation (WEDC) regional partners. Businesses must apply through the partner organization for the region in which they are located. Applications are open through June 30, 2022.

### Wisconsin Emergency Rental Assistance Program - Help Is Still Available

The Wisconsin Emergency Rental Assistance Program (WERA) provides up to 18 months of assistance with current or overdue bills to help households that have been impacted by the COVID-19 pandemic avoid eviction. More than 25,000 Wisconsinites have already received help with rent, utilities, and internet or broadband statewide. Help is still available for eligible households through WISCAP agencies and Energy Services. The program is funded by the Federal Emergency Rental Assistance Program and administered by the Wisconsin Department of Administration.

# Gov. Evers Announces \$5 Million Investment to Expand Access to Telehealth Services

Gov. Tony Evers, together with the Wisconsin Department of Health Services (DHS), this week announced <u>a \$5 million investment</u> to make telehealth services, including mental and behavioral health services, more accessible by bolstering child psychiatry telehealth services and establishing neighborhood telehealth access points. Funded by the American Rescue Plan Act, DHS will use \$2.5 million of the investment to create a new grant program for hospitals and health systems to expand and enhance child psychiatry telehealth services. Through this program, up to five one-year grants of approximately \$500,000 will be awarded to hospitals and health systems across the state. Applications are due by 3 p.m., Fri., May 6, 2022. The remaining \$2.5 million will be used for a grant program for providers to partner with community organizations to establish neighborhood telehealth access points at food pantries, homeless shelters, libraries, long-term care facilities, community centers, and schools for people with limited access to technology and reliable internet service. One-year grants of up to \$100,000 each will be awarded to between 25 and 50 providers across the state. Applications are also due by 3 p.m., Fri., May 6, 2022. # Gov. Evers, WEDC Announce Main Street Bounceback Grants Have Helped More Than 3,400 Small Businesses Open Storefronts in All 72 Counties

In April 2021, Gov. Evers <u>announced</u> the state would dedicate \$50 million toward helping small business owners open physical locations and communities fill vacant storefronts. An analysis from November 2021 showed that as a share of federal pandemic aid the state has received and directed by Gov. Evers, Wisconsin ranked second in the country for aid directed to economic development, and first in the country in aid allocated to businesses.

Funds for the Main Street Bounceback Grant Program are provided by the federal American Rescue Plan Act. The program is still open to new or existing businesses opening a new location or expanding operations in a vacant commercial space as of January 1, 2021. # Gov. Evers Announces \$8 Million to Help Wisconsinites Access Civil Legal Services Needed to Recover from Pandemic

Gov. Tony Evers this week also announced an \$8 million grant to support Wisconsinites who need legal assistance to recover from the COVID-19 pandemic. The grant will be made to the Wisconsin Trust Account Foundation Inc. (WisTAF) to fund civil legal aid organizations statewide and to build a Wisconsin Law Help website, a user-friendly online legal assistance portal that will help Wisconsinites access accurate legal information.

The grant will allow WisTAF and its partner organizations to furnish civil legal aid interventions to Wisconsinites who face foreclosure, eviction, and other housing-related problems due to COVID-19; need legal assistance to access unemployment benefits, workforce opportunities, or health coverage; or still struggle with other economic hardships related to the pandemic.

## More than \$57 Million Awarded Through Diverse Business Assistance Program



Gov. Tony Evers last week announced \$57.6 million in grants were awarded through the Diverse Business Assistance Grant Program to 24 chambers of commerce and nonprofit organizations providing assistance to small businesses.

These grants will support the work of chambers of commerce across the state in providing coaching and mentoring, technical assistance, equipment and internet services, digital literacy, online marketing and social media training, financial aid, and financial literacy support, as well as networking and

educational opportunities for new business owners and emerging entrepreneurs. A list of grant awardees and additional information can be found on the <u>program website</u>.

### \$28 Million Allotted to Community Development Financial Institutions

Gov. Tony Evers last week also announced another \$28.8 million in grants were awarded through the Diverse Business Investment Grant Program to nine Community Development Financial Institutions (CDFIs).

These CDFIs support micro and small businesses not only through lending and providing access to capital and credit, but many also support programs that provide additional technical assistance, coaching and mentoring, and credit counseling. These grants will help these institutions continue to bolster and ignite economic and business growth in Wisconsin. ### \$50 Million Investment for Safer Communities

Gov. Tony Evers last month announced more than \$50 million investment for community safety, \$36 million of which will go to statewide programs to support local and Tribal law enforcement agencies and funding to help alleviate the pandemic-related backlog of criminal cases. All local and Tribal law enforcement agencies will be able to receive funds for eligible costs. This brings the governor's overall investment into violence prevention and public safety to more than \$100 million, including a \$45 million investment announced last year to support violence prevention efforts and crime victims.


